Basic Benefits

- Improve Departmental and Agency efficiency.
- Eliminate \$1.62B in excessive commuting expenses of employees in Washington DC alone.
- Provide agency and department employees a significant indirect economic boost.

- Recycle and renew unused assets in each community to which a Department Headquarters is relocated.
- Reduce cost of agency and department facilities by moving them out of old costly monumental buildings into updated renovated or new building that are also carbon print sensitive.
- Lower Federal annual budget through the sale or leasing of the old monumental buildings.

National Security Benefits

- Recycle government office buildings allowing them to be converted to housing in Washington, D.C. This would foster growth in the private sector and put the buildings to positive use: housing.

Reduce the cost of living Locality Adjustment for most department employees, thus avoiding cost of living adjustments to federal salaries, which is 28.22% in 2018. A potential savings of \$1,794,893,592 per year. Enough to pay for all moves in the first year alone. Based on total employees moved 106,006, average salary \$60,000.
